

PROFILE

Sudhanshu Batra is a practicing Senior Advocate at the Supreme Court of India, the Delhi High Court and various Tribunals since the year 1986. He studied at St. Xavier's School, Delhi. Completed graduation in Economic (Hon.) from Hansraj College, Delhi University and L.L.B from the Faculty of Law, Delhi University.

He initially joined late Hon'ble Ms. Justice Sunanda Bhandare, while her Ladyship was an Advocate on Record, Supreme Court of India and upon her elevation as Judge of the High Court, Mr. Batra joined Singhania and Co, Advocates and Solicitors and looked after the firms work at the District Courts and High Courts. Soon thereafter he started independent practice.

He has practiced in diverse fields of law including Property Law, Company Law, Arbitration Law, Family Law, Matrimonial laws, Writ laws, Construction law, Banking Law, employment Law, Labour Law and various other Commercial laws. With a wide experience in appearing before the Supreme Court, High Courts, NCLT (formerly the Company Law Tribunal), DRT etc. he has helped the legal Institution in developing law in various fields. Mr. Batra, was designated as a Senior Advocate by the Delhi High Court in the year 2010.

He has represented a large number of PSUs, Banks and private companies/organization, partnership firms, various legal entities such a Trusts, Cooperative Societies, Schools, HUFs besides families and individuals etc.

Mr. Batra has extensively appeared as Counsel in numerous Arbitration proceedings for both domestic and International Arbitrations. The arbitration proceedings include matters pertaining to disputes arising out of EPC, Infrastructure Contracts, Builder and Buyer contracts, tenancy disputes, sale of goods contracts etc. He has also been appointed arbitrator in close to one hundred arbitration disputes between the parties. He has been appointed, not only by parties to the disputes but also by various courts, to act as either a sole Arbitrator or in the panel of Arbitrators constituting the Arbitral Tribunals. He is also on the panel of Arbitrators, maintained by the Delhi International Arbitration Center (DIAC).

He is also a Trained Mediator and has been the Organizing Secretary of the Delhi High Court Mediation and Conciliation Centre (Samadhan) between 2011 to 2017.

He received his basic and advance Training in mediation at Delhi, India. He completed the 'Train the Trainer' ('TOT') program from the S.J. Quinney College of Law, University of Utah, USA and attended a program on 'Advance Seminar on mediating effectively' at the Strauss institute for Dispute Resolution, University of Pepperdine, Malibu, USA. Besides having conducted hundreds of private and court annexed mediations, he has trained lawyers of several High Courts, district courts, consumer courts across the country as well as Judicial Officers at Delhi, Chandigarh, Bangalore and Rajasthan etc. He has also conducted workshops for students at various law schools. He has been appointed an observer by the Mediation and Conciliation Project Committee (MCPC) of the Supreme Court of India for observing the

training of trained Mediators. He is regularly appointed mediator in several important and large commercial disputes by the Supreme Court, the Delhi High Court, NCLT and Arbitration Tribunals. He has conducted mediations relating to Family disputes, Commercial Disputes, IPR disputes, disputes relating to Companies Law besides matrimonial disputes amongst others. During the pandemic, Mr. Batra has also been conducting Online mediations specially in Commercial and Family disputes.

Mr. Batra is presently a member of the Overseeing Committee of the Delhi High Court Mediation and Conciliation Centre and is empaneled as a Mediator cum Trainer with Samadhan. He is a member of the Singapore International Mediation Centre (SIMC) and was a Founder member and former Vice President of Maadhyam, Council for Conflict Resolution and is presently a Trainer and Mediator with CAMP, Arbitration and Mediation Practice Pvt. Ltd., Bangalore. He is a former elected Senior designated member of the Delhi High court Bar Association during the period 2019-2022 and is a member of PHD Chambers of Commerce and Industries. During the period 2019-2022, he was the elected Senior Designated Executive member of the Delhi High Court Bar Association.
