Dr. Aarushi Jain leads the education, projects and outreach activities at the Bharti Institute of Public Policy at Indian School of Business, being the Policy Director of the Institute. A continuous learner, Dr Jain holds a Ph.D. (Social Sciences), Masters (Public Administration), Masters (Human Rights), and has been a UGC-Sr. Research Fellow and an Accredited Management Teacher (AMT) in Public Policy. Her recent certifications include an Accelerated Leadership Programme at ISB, Executive Education Course in Digital Transformation from ISB & AWS and Evaluating Social Programmes course from MIT-J Pal and a course on Evidence in Public Policy from Oxford University.

In her current role, Dr Jain leads engagements with various ministries in Govt of India, state governments and international organisations. As the Policy Director, she coordinates the engagements with the states of Punjab, Himachal Pradesh, Goa, Odisha, Jharkhand, Tamil Nadu, Karnataka, Telangana and Andhra Pradesh. She has been guiding the development and outreach of the 'India Data Portal', a project funded by Bill & Melinda Gates Foundation, since its inception in 2018. She is now working with states of Himachal, Meghalaya and Goa to develop their respective state open data portals. Dr Jain leads the development on Public Policy case studies at the Bharti Institute, including cases under ISB-LBSNAA collaborative case series. She is driving the engagement with Department of School Education in various states on research and training, where already 10,000 principals and school heads have been trained on 'Leadership and Motivation'. She is providing thought leadership to the Meghalaya Legislative Research Fellowship Initiative of Govt. of Meghalaya where ISB is the knowledge partner. She is the Course Coordinator of the Advanced Management Programme in Public Policy (AMPPP) at ISB, which is a one-year long-term domestic training programme for civil servants in India.

Dr Jain is a visiting faculty in premier institutions, including Lal Bahadur Shastri National Academy of Administration (LBSNAA), Himachal Institute of Public Administration (HIPA), Indira Gandhi National Forest Academy (IGNFA), National Academy of Customs, Indirect Taxes & Narcotics (NACIN) etc. She has recently co-authored a book on 'Cyber Laws and Cyber Crime', Oct 2021 edition. Her previous book was on 'Public-Private Partnership and Corporate Social Responsibility' and she has more than 40 publications in leading journals. She is the series editor of the ISB-Routledge Policy Book Series titled "Innovations, Practice and Future of Public Policy in India". Her research interests include Public Policy issues especially relating to Good Governance, Ethics in Policy, Digital Governance, Women Empowerment, Rural Development and the Education sector.
